IN THE MATTER OF HUMAN RIGHT ABUSE OF SENIOR HIGH SCHOOL STUDENTS
RE:ANNOR ADJAYE SENIOR HIGH SCHOOL(SHS)
REQUEST FOR DISCIPLINARY COMMITTEE REPORT

I act as Solicitor for and on behalf of Human Rights Reporters Ghana(HRRG) a nonprofit human right advocacy group made up of journalists and human right advocates (hereinafter called "my Client") and on whose express instructions I write to you.

My Client informs me of an awful case of human right abuses against some students of the Annor Adjaye SHS by some teachers for which your outfit claimed to have investigated and punished the said teachers involved in the unlawful conduct.

My Clients further informs me that by a letter dated 7th day of July, 2022 a request for the report of the committee established to investigate the said teachers was made to your outfit, however you have since failed to grant my Client's request.

I wish to indicate to your outfit that my Clients being an entity properly registered under the laws of the Republic of Ghana and being a Human Rights Advocacy group that advocates against Human rights abuses and ensures Human Rights protection for the vulnerable, are entitled under **ARTICLE 21(1)f of THE CONSTITUTION 1992** and **RIGHT TO INFORMATION ACT 2019(ACT 989)** to be furnished with the said Committee Reports as requested for. Thus your failure to fulfill my Client's request will not only be unlawful, but also a violation of their constitutional rights.

We therefore humbly request for the following;

- a. Certified copies of the entire proceedings and hearing of the Disciplinary Committee, and


